MEDICAL RELEASE

I, Parent or Legal Guardian, hereby consent to my child's participation in the Camp. My child is in good health and can participate in all activities. Therefore, in consideration for the services to be performed by Emerald Gems, I, on behalf of my child, do further release, covenant not to sue, discharge, and hold harmless Emerald Gems and its affiliated entities, parent entities, subsidiaries, officers, directors, agents, employees, organizers, representatives, successors, assigns, and any others associated with the Camp (the "Released Group") from any and all claims or liability to us or my child for any damages or injuries which may be sustained by my child arising out of or in connection with the Camp.

In the event that reasonable attempts to reach my child's Parents, Legal Guardians, and Emergency Contact at the phone numbers listed on the Registration Form have been unsuccessful, I hereby give consent for (i) the administration of any treatment deemed necessary by the preferred physician listed on the Registration Form or by another licensed medical professional and/or (ii) the transfer of my child to the nearest appropriate hospital or emergency facility. This authorization does not cover the performance of major surgery on my child unless the medical opinions of two licensed physicians or other medical professionals, concurring in the necessity for surgery, are obtained prior to performance of surgery.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury or illness resulting from exposure to COVID-19 (including, but not limited to, personal injury, disability, and/or death) to myself, my children and my family. I understand that any time a camper or parent feels like the risk is too great to the camper or their family, the camper may decide to leave or not attend the Camp.

exposure to COVID-19, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Released Group, whether a COVID-19 infection occurs before, during, or after participation in the Camp.

I, hereby understand that the following guidelines are based on the current safety regulations in response to the current COVID-19 pandemic and agree that each of the children listed below should not attend the Camp if he/she (1) Is feeling ill or running a temperature of more than 100.4 or higher; (2) Has had a temperature of 100.4 or higher or a sense of having a fever in the past three days; (3) Has tested positive for COVID-19 in the past 14 days or has knowingly been in close contact (within 6 feet of someone for a total of 15 minutes or more) with someone who has tested positive for COVID-19 or has COVID-19 symptoms in the past 14 days.

By signing this agreement, I also represent and warrant that I, along with all of the members of my family, have received, understand and agree that we will follow all of the precautions put in place by Emerald Gems and its host facility.
